Pursuant to A.R.S. § 38-431.02, notice is hereby given to the general public, the parties, and the Arizona Power Plant and Transmission Line Siting Committee (“Committee”), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Hampton Inn and Suites located at 2000 North Litchfield Road, Goodyear, Arizona 85395, commencing on February 23, 2026 at 1:00 p.m., and will continue each weekday on February 24, 2026, through February 27, 2026, as necessary, at the same location beginning at 9:00 a.m. on each day.

Public comment will be taken in a special evening session on February 23, 2026, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman of the Committee (“Chairman”). Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each

1 day, except on February 23, 2026, when it will continue after 5:30 p.m. for the public
2 comment session.

3 The hearing may conclude earlier or later than anticipated, depending upon the
4 number of parties that intervene, the amount of testimony presented, the amount of public
5 comment, and the time needed for deliberations by the Committee.

7 **WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING VIA**
8 **TELEPHONE.**

9 At least 24 hours in advance of the hearing, information regarding online and

11 other revisions to the hearing schedule, will be posted on the Applicant's Project website

14 may, at his discretion, recess the hearing to a time and place to be announced during the
15 hearing, or to be determined after the recess. The date, time, and place at which the
16 hearing will be resumed will be posted on the above-noted Project and ACC websites.
